

RAPTORS PROMOTION RULES AND REGULATIONS

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who entered on raptors-related posts at @familyllb on Instagram OR on the *Russell Alexander Collaborative Family Lawyers* Facebook page and who are 19 years of age or older as of the date of entry. The Campaign is only open to legal residents of Ontario, Canada, and is void where prohibited by law. Employees of Russell Alexander Collaborative Family Lawyers, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign.
